## Mediterranean Caritas call for safe and open channels of legal entry to the EU

Caritas Europa together with Caritas Italy, as a leading organisation of the Migramed(1), and in light of the upcoming Italian Presidency of the Council of the EU, call the EU and EU Member States to provide save and legal entry to seek international protection for refugees as well as legal channels for labour migration all across the EU.

We urge the EU and all EU Member States to adopt the following concrete measures:

- Introduce humanitarian visa that is easily accessible through embassies from countries of origin and transit and are affordable;
- Facilitate **family reunification** for refugees and migrants to join their families in the EU;
- Consider **interchangeability of embassies** of different EU Member States to allow easier access to them in third countries;
- Extend the **humanitarian admission** programmes;
- Engage in more **resettlement**.

All these measures will only work well once the EU also implements **legal channels for labour migration** along with it.

Moreover, the European Union must comply with its **international obligations for human rights protection at EU external borders** including **search and rescue operations**. Violence (by police or other actors) – witnessed by Caritas organisations against migrants at the borders – has to be stopped in countries of origin, transit or destination and the EU should step out to enforce international obligations in this regard in third countries.

We call on the transit countries and countries of origin:

- To enable and facilitate the safe and legal channels of entry to the EU;
- Not to restrict the freedom of movement and to comply with the **right to leave any country** including one's own, for instance by speedy access to travel and identity documents.

Lives are being lost every day at the external borders of the EU. These human tragedies need to be addressed as soon as possible. People come to Europe to seek international protection or to seek a better life. One of hundreds of tragedies happened in October 2013 off the isle of Lampedusa where 366 migrants drowned in the sea. Europe cannot turn a blind eye to these incidents.

Caritas appreciated the **European Parliament** <u>adoption of a resolution</u> in which it is well highlighted that "EU legislation provides some tools, such as the Visa Code and the Schengen Borders Code, which make it possible to grant humanitarian visas" and that "legal entry into the EU is preferable to a more dangerous irregular entry, which could entail human trafficking risks and loss of life". Also the <u>Task Force Mediterranean</u> has been created to prevent further loss of lives at EU shores.

We need some tools which constitute "an out-and-out answer" from "an EU based on solidarity and concrete support", as Cecilia Malmström said by the creation of the Task Force Mediterranean. **Ends**
